

ORDINANCE NO. 10
CONCERNING SIDEWALK IMPROVEMENTS

BE IT ORDAINED BY THE TOWN BOARD OF HUDSON, COUNTY OF WELD AND STATE OF COLORADO:

WHEREAS the following petition has been received, by this Board of Trustees, praying for sidewalk improvement, the said Board herewith orders the petition in full hereto appended and made a part of this ordinance:

P E T I T I O N

TO THE HONORABLE MAYOR AND COUNCIL OF THE TOWN OF HUDSON

We the residents and property owners of Blks 8, 64, 49, 47, 50, and 63 in the town of Hudson, do petition you to construct or cause to be constructed a cement side-walk, beginning at the North-west corner of Blk No. 10 (School ground), Thence North across 4th Avenue to the Southwest corner of Block No. 7, thence West on North line of 4th Avenue, across Cherry St., along the South line of Blk No. 8, across Beech st. to the South-east corner of Blk No. 64, thence North along the west side of Beech st. along the east line of Blk No. 64, North across 5th Avenue to the South-east corner of Blk No. 49, thence West on the North side of 5th avenue along the South line of Blk No. 49 to the South-west corner of said Blk 49, thence North along the East side of Ash st. along the West side of Blk 49, across Main st to the South-west corner of Blk No. 48 thence West along the North side of Main st. to the Right of Way of the C. B. and Q. R. R. .

And also beginning again at the South-east corner of Blk 64 and running West along the North Side of 4th Avenue along the South line of Blk. 64 across Ash st to the south east corner of Blk No. 63, thence North on the West side of Ash street along the East side of Block 63, across 5th avenue and along the east side of Blk 50, across Main st. to South east corner of Blk 47.

Also crossing from South east corner of Blk 50 across Ash Street to the south west corner of Blk No. 49 across Beech street to Blk One Ireland addition.

Also beginning again at the North east corner of Blk 49 and thence North across Main street to the South east corner of Blk 48, thence west on north side of Main st. to the South west corner of said Blk 48.
