ORDINANCE ADOPTING BUDGET

ORDINANCE NO. 61

AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF HUDSON, COLORADO, FOR THE FISCAL YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 1963, AND ENDING ON THE LAST DAY OF DECEMBER, 1963, ESTIMATING THE AMOUNT OF MONEY NECESSARY TO BE RAISED BY TAX LEVY BASED ON THE SAID BUDGET SO ADOPTED; ESTIMATING THE AMOUNT OF MONEY TO BE DERIVED FROM OTHER REVENUE SOURCES; AND SETTING FORTH THE TOTAL ESTIMATED EXPENDITURES FOR EACH FUND.

WHEREAS, Charles A. Taylor & Associates, Certified Public Accountants, of Brighton, Colorado, designated to prepare the annual budget for the Town of Hudson, Colorado, for the fiscal year beginning January 1, 1963, and ending December 31, 1963, has prepared said budget and submitted it to the Board of Trustees, and

WHEREAS, the Board of Trustees held a public hearing on said budget on October 9, 1962,

AND, WHEREAS, the assessed valuation of taxable property for the year 1962 in the Town of Hudson, as returned by the County Assessor of Weld County, Colorado, is the sum of \$352,900.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF HUDSON, COLORADO:

Section 1: That the estimated revenue for the various funds of the Town of Hudson is:

Section 2. That the estimated expenditures for each fund of the Town of Hudson are as follows:

General Fund	\$ 6,239.50
Library Fund	\$ 413.74
Water Fund	\$ 8,207.50

Section 3. That the budget for the Town of Hudson, Colorado, for the fiscal year beginning January 1, 1963, and ending December 31, 1963, as heretofore submitted to the Board of Trustees by Charles A. Taylor & Associates, Certified Public Accountants, of Brighton, Colorado, and as changed and amended by said Board of Trustees be, and the same hereby is adopted and approved as the budget for the Town of Hudson for said fiscal year.

Section 4. That the budget herein approved and adopted shall be signed by the Mayor and the Town Clerk, and made a part of the public records of the Town of Hudson.
