TAX LEVY ORDINANCE

ORDINANCE NO.62

AN ORDINANCE LEVYING TAXES FOR THE YEAR 1963, TO DEFRAY THE COSTS OF MUNICIPAL GOVERNMENT OF HUDSON, COLORADO FOR THE FISCAL YEAR BEGINNING JANUARY 1, 1963 AND ENDING DECEMBER 31, 1963.

WHEREAS the Board of Trustees of the Town of Hudson has adopted a budget for the fiscal year beginning January 1, 1963 and ending December 31, 1963;

AND, WHEREAS, the Board of Trustees has determined that the proper mill levy upon each dollar of the assessed valuation of all taxable property within the Town of Hudson is 22.38 mills.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF HUDSON, COLORADO:

Section 1. That for the purposes of defraying the expenses of the General Fund of Hudson, Colorado, during the fiscal year beginning on January 1, 1963, and ending on December 31, 1963, there is hereby levied a tax of 16.05 mills upon each dollar of the total assessed valuation of all taxable property within the Town of Hudson, Colorado for the year 1963.

Section 2. That for the purpose of defraying the expense of paying the interest upon and the principal of outstanding bonds of the Town of Hudson coming due in the fiscal year beginning January 1, 1963, and ending December 31, 1963, there is hereby levied a tax of 5.21 mills upon each dollar of the total assessed valuation of taxable property within the Town of Hudson, Colorado, for the year 1963.

Section 3. That for the purpose of defraying the expense of operating and maintaining a Public Library during the fiscal year beginning January 1, 1963, and ending December 31, 1963, there is hereby levied a tax of 1.12 mills upon each dollar of the total assessed valuation of all taxable property within the Town of Hudson, Colorado, for the year 1963.

Section 4. That the Town Clerk is hereby authorized and directed to immediately certify to the County Commissioners of Weld County, Colorado, the total tax levy for the Town of Hudson, Colorado, as is herein set forth.
